Notice is hereby given, the Cambria County Transit Authority (CamTran) located in Johnstown and Ebensburg, PA, is soliciting bids for proposed renovations to CamTran's Rural Facility in Ebensburg, PA.

The deadline for bid submissions is 2:00 pm (EST) on Thursday, May 3, 2018. All bids will be publicly opened and read aloud at this time and date. A NON-MANDATORY PRE-BID meeting will be held at the project location, 1226 North Center Street, Ebensburg, PA 15931 on April 4, 2018 at 1:00pm (EST).

CamTran encourages the use of Disadvantaged Business Enterprise (DBE) in all contracts. Any certified DBE'S proposed by the contractor must be fully utilized with adequate documentation provided by the selected contractor to satisfy federal and PennDOT requirements. A DBE goal of 5.42% has been established for each contract. Federal Prevailing Wage Rates are required for this project.

Sealed bids shall be submitted on unaltered bid forms in sealed envelopes clearly marked “**CamTran Rural Facility Renovations Project**”.

The Bidder’s attention is directed to the fact that all applicable Federal and State laws, municipal ordinances and codes, and the rules and regulations of all authorities having jurisdiction over construction of the Project shall apply to the Contract throughout, and they are deemed to be included in the Contract the same as though herein written in full.

CamTran will not be liable for any costs incurred in the preparation of the bids or attendance at the pre-bid conference.

All bids and contracts are subject to a financial assistance contract between CamTran and the Pennsylvania Department of Transportation and or the Federal Transit Administration.

All bids shall be accompanied by cash, a certified check, cashier’s check, bank good faith check, made payable to the Cambria County Transit Authority (CamTran), or other irrevocable letter of credit drawn upon a bank authorized to do business in the Commonwealth or by a bid bond with corporate surety equal to 10% of the base bid total.

The successful bidder will be required to comply with all applicable Non-Discrimination and Non-Collusion laws and regulations to certify that they are not on the Comptrollers General’s list of ineligible contractors. CamTran solicits and encourages Disadvantaged Business Enterprise (DBE) participation. A DBE goal of 5.42% has been established for each contract. The successful bidder will be required to comply with all applicable EEO laws and regulations.

CamTran provides equal opportunity in employment, service and contractual agreements.

**This project will require Federal Davis-Bacon prevailing wage rates.**

The bidder agrees that bids will be valid for at least a ninety (90) day period from the date the bids are opened. CamTran reserves the right to reject any or all bids and to waive any or all irregularities, mistakes, omissions or informalities relative thereto.
