V. Executive Director's Report

Inclined Plane:

- October 13 & 14 Commissioning was done.
- Dept of Labor & Industry and State Safety Oversight conducted the inspections.
- There were minor items that are easily fixable. Once they are fixed, Labor & Industry will return.
- A credit to Bob, Skip, and Tom Batzel. Commissioning usually takes three weeks, and it was done in two days.
- Kim was involved with the construction committee and moved things along and got in early.
- Two operators were rehired and one internal position for conductors, another full-time operator is still needed.
- · We're hoping to reopen at the end of the year.

Ebensburg Project

- · Kick off began three weeks ago.
- Painting for the bus storage garage is almost finished.
- Doing prep work for the fire suppression equipment.
- Electrical conduits have been installed at the storage garage.

Mode Shift

- On track to move forward.
- A lot of behind-the-scenes work.

A. Finance Committee

i. Treasurer's Report

Thomas Gramling, Treasurer, gave the Treasurer's Report from the Finance Committee meeting held today at 08:30 a.m.

In attendance: Joe Slifko, Ed Dreikorn, Trish Corle, Thomas Gramling, and Rose Lucey-Noll.

ii. Approval of financial statements, for September 2025, as reviewed by the Finance Committee.

Rose Lucey-Noll reviewed the financial statements:

- We are in the third quarter and financially stable.
- Revenue is up 15.55 %, comparison to the budget we are up 20.88%.
- Expenses are under by 9.21%; compared to the budget, down 6.37%.
- Performance measures: we're meeting 3 of the 4 goals. We're very close on revenue per vehicle hour.
- Fixed Route YTD is down 3%
- Reserve-a-Ride/Shared Ride/non-Public Transportation which is MATP, is up 371%.
- ADA is up 1%; Total Ridership is up 9%.
- Safety had one preventable and zero non-preventable accidents.
- Solar no report. The meter is down.
- Preventative maintenance is 100%
- Miles between failures in Johnstown and Ebensburg are meeting our targets.



Joe Slifko entertained the motion for approval of financial statements, for September 2025, as reviewed by the Finance Committee.

Questions, concerns, and abstentions: Rose Lucey-Noll explained this is something we do every year and are obliged, like every other transit agency. Ours is unusual because we also have the Inclined Plane. We have a safety plan in place and every year it gets reviewed and revised.

Justin Kipp, CSO, explained there are two PTASP's. One for the bus, one for rail. Because we are a rail transit agency, we're subject to PTASP's just like SEPTA and PRT. We are just shy of 900 feet of rail so we get the same treatment as hundreds of feet of rail.

The motion was unanimously approved.
